Mike Bednarz from the Port Authority:


- The Joint Cargo Study with the NYC development Corporation will be release soon.

Joe Pesce: On February 7th we have a dinner with the Freight Brokers Association. At Joel's request we are going to meet with key handling agents to discuss service levels at JFK.

Anthony Affissio from the FAA Hazmat:

- Anthony introduced **Trevor Nelson** a new member of the FAA team.
- Anthony brought hand outs about important telephone numbers and website for the FAA as well as a proposed rule making about lithium batteries (I will forward both of them by a separate e-mail)
- Concerning the report by the CBP about contaminated metals, as far as we are concerned this is undeclared Hazmats that should be reported to us so we can take action.
- There are a lot of anendments that have been made by ICAO and IATA. As far as lithium batteries so far the US has not adopted and harmonized changes that have been made since 2009 by IATA and ICAO. It would be a good thing for carriers to comment on the notice for proposed rule making on lithium batteries so everybody could be on the same page. The US regulations date back to 2008 and do not carry the added safety regulations adopted by IATA and ICAO.

Wally Luber from KLM and U.S.P.S. Team Leader for Kaamco Cargo:

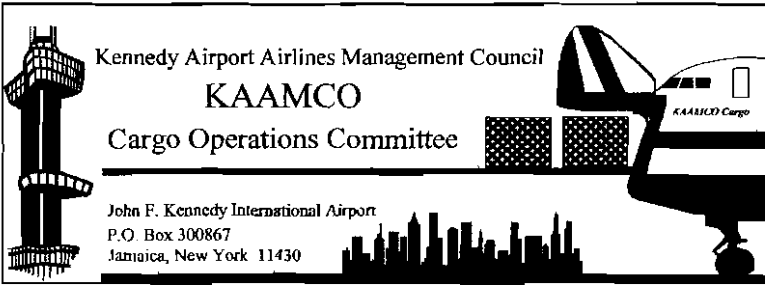
- There are over 100 ulds at post P. In addition there is live mail beyond the New Jersey barrier which is interfering with the taxiway. I also found pilfered mail. Make sure that mail is delivered on the post office compound, a secure location. Leaving live mail at post P is a danger.
- It seems that some companies don't even bother to bring the mail inside the post office area but others are told that there is no room and are told to leave it outside.
- Because of the horrendous conditions at the post office Air France and KLM place an embargo on mail coming to JFK during the holiday seasons.

Alex Malaiko Postal Inspector:

- We are not involved with the processing of inail but we are involved with security. We handle postal thefts at JFK with other law enforcements here. We also have an export team. My number is 718 553-9168. The Postal Police 24h number is: 718 553-7372.
